Effective August 1, 2021

Effective August 1, 2021, Minnesota Statutes, section 168.12 increased plate fees and are reflected below.

Duplicate Title Fee\$7.25 Duplicate Cab Card\$1	
Expedited Title Fee\$20	
Filing Fee <ul style="list-style-type: none"> • Renewals Only\$7 • All Other\$11 	Applies to each transaction.
Late Transfer Penalty\$2	Due when a transfer is not submitted within 10 business days of the date-of-sale.
Lien Fee (Grant).....\$2 Assignment of Lien.....\$1	There is no fee for a duplicate lien card. However, a deputy registrar may charge the \$11 filing fee.
Non-Title Transfer\$3	Due on non-title transfers occurring after initial MN registration issued.
PSV Fee.....\$3.50	Public Safety Vehicle Fee Due on initial applications for title and title transfers. Do not charge this fee on non-titled trailer transactions.
Registration Technology Surcharge\$2.25	Effective with registration renewal applications submitted on or after Aug. 1, 2019. It is not due on initial applications for Minnesota registration/title. Also see: Title Technology Surcharge. <i>Note: only one technology surcharge is due with a renewal is done in conjunction with a Minn. title transfer (effective Jan. 2020).</i>
Registration Tax	Refer to Tax Manual .
Sales Tax6.5%	Due on the net purchase price of the vehicle unless the purchase is exempt from sales tax or qualifies for an in lieu tax: <ul style="list-style-type: none"> • \$10-In-lieu Tax – charge on passenger vehicles, ten model years or older, when the purchase price and fair market value is under \$3,000. If the fair market value or purchase price is \$3,000 or more, the vehicle does not qualify for the in-lieu tax. • \$150 In Lieu Tax – Charge on passenger class vehicles and fire trucks registered in a collector class.
Salvage Inspection Fee ...\$35	Due for inspections of salvage vehicles only.

Title Fee\$8.25	Due on initial applications for title and title transfers. This includes: <ul style="list-style-type: none"> • Each issuance of a title • Repossessions • Corrected titles
Title Technology Surcharges.....\$2.25	Effective with applications submitted on or after Aug. 1, 2019. Does not apply to changes in lease information or when adding or removing a lienholder from a title. <i>Note: Only one technology surcharge is due on a Minn. title transfer that includes a registration renewal (effective Jan. 2020).</i>
Transfer Tax.....\$10	Due on initial applications for title and title transfers. Do not charge on: <ul style="list-style-type: none"> • Transfers from joint to single ownership (<i>The fee is due on transfers from single to joint ownership.</i>) • Applications in the name of a licensed dealer, when the dealer is holding the vehicle for resale • Applications in the name of a government entity • Applications in the name of the owner listed on the foreign state title or registration card being surrendered. • Applications for vehicles weighing less than 1,000 pounds
