

# 2024 Legislative Bulletin

June 30, 2024

This bulletin summarizes laws enacted during the 2024 regular legislative session that impact and are of interest to DVS staff and business partners.

# What you need to know:

• DVS will translate materials into qualifying languages; with priority given to material most frequently distributed to the public.

- If translated documents are requested, but not in a qualifying language, requested materials will be provided within 30 days of the request.
- In consultation with the commissioner of administration and organizations representing non-English speaking people, DVS will identify locations who service a substantial number of non-English speaking people and if that population has access to equivalent materials in a qualifying language. Equivalent materials in qualifying languages will be provided to these locations free of charge.
- Report due by February 1, 2026.

# Deputy Registrar and Driver's License Agent Ownership Limitations

#### What you need to know:

- Creates new subdivision stating that a kiosk vendor cannot have an ownership interest with a deputy registrar (DR) or driver's license agent (DLA), and a kiosk vendor is not eligible to be appointed as a DR or DLA.
- Language added stating an approved company providing Electronic Vehicle Title and Registration (EVTR) services cannot have an ownership interest with a deputy registrar (DR) or driver's license agent (DLA), and a company providing EVTR services cannot be appointed as a DR or DLA.
- The statutory change does not apply to DRs or DLAs who were appointed prior to the placement of a kiosk in an existing office.

# Competitive Bidding of Deputy Registrar and Driver's License Agent Offices

# What you need to know:

- Competitive bidding process must be established to appoint a replacement deputy registrar or driver's license agent. The commissioner must adopt rules to administer and enforce the process.
- If available, services will continue to be offered by the replacement DR or DLA at the same location. If that location is not available, the new location must be approved by the commissioner and must service a similar service area as the existing office location.
- If the replacement DR or DLA elects to not offer services at the existing office location, Minnesota Rules chapters 7404 & 7406, governing the selection of a proposed office location for a deputy registrar or driver's license agent, applies.

# **Limited Licensing Agents as Full-Service Providers**

- A limited licensing agent appointed before January 1, 2024, may apply to become a full-service provider at the agent's current office location.
- Application must be submitted on or before June 1, 2025, and the applicant must satisfactorily complete any additional staff training required by DVS by June 30, 2025, before they can offer expanded services as a full-service provider.
- Appointments under this section are subject to Minnesota rules chapter 7404 with the exception of 7404.0300, subparts 4, 5, and 6; 7404.0305, subpart 1, item B; 7404.0345, item D; 7404.0350; 7404.0360, subpart 2; and 7404.0400, subpart 4, item B.

## **Traffic Safety Camera Pilot Project**

- Establishes a traffic safety camera system pilot program in the cities of Minneapolis and Mendota Heights that provides for education and enforcement of speeding violations, traffic-control signal violations, or both in conjunction with use of traffic safety camera systems beginning August 1, 2025, through July 31, 2029.
- Definition of red-light camera system, speed safety camera system, and traffic safety camera system added.
- Outlines penalties for violation of a traffic-control signal or speed limit identified through the use of a red light or speed safety camera system and the limitations of these violations.
- Violation will not be recorded on an individual's driving record unless the violation occurs in a commercial motor vehicle or is committed by a holder of a commercial driver's license or learner's permit.
- A fine or conviction through this system does not constitute grounds for revocation or suspension of a person's driver's license unless the violation occurs in a commercial motor vehicle or is committed by a holder of a commercial driver's license or learner's permit.

- Definitions of electric-assisted bicycle and equipment expanded, and definition added for multiple mode electric-assisted bicycles.
- A section related to electric-assisted bicycles will be added to the driver's license manual.

## **Commercial Driver Workforce Study**

- Joint study with the Department of Transportation to address commercial driver shortage in transportation and transit sectors.

## **Driving Rules – Lane Sharing**

## What you need to know:

- Creates a traffic violation or offense for a driver to intentionally impede or attempt to prevent the operation of a motorcycle when operated under the conditions specified in section 169.974, subdivision 5, paragraph (g).
- Allows limited traffic lane sharing by motorcycles with other motor vehicles.
- Statewide public education campaign to be implemented.

## **Temporary Mailing Address**

# What you need to know:

- Allows identify verification for a program participant in the Transportation Security Administration's Registered Traveler program who has voluntarily provided their license or identification card to confirm their identity.
- Information provided for identity verification is limited to name, date of birth, license or identification card number, issuance and expiration date, and credential security features. Does not include facial recognition.

# **Child Passenger Restraint Systems**

Adds new definitions for "child passenger restraint system" and other terms.

• Moves the Minnesota child passenger restraint and education account from the state treasury to the special revenue fund.

# **Clipping of Driver's License**

# What you need to know:

 Peace officers are no longer required to clip the upper corner of a driver's license or permit card when it is being invalidated.

• Driver's license agents and deputy registrars should continue with their current practice of perforating invalidated cards.

# **License and Identification Card Application Content**

- Adds applicant's height in feet and inches, weight in pounds, eye color, and sex as required information contained on an application.
- Dept. of Corrections or Federal Bureau of Prisons identification card removed as an acceptable secondary document for proof of identity.
- License and identifications cards must only be issued to an individual with a residence address in the state at time of application. Only one residence address per individual at any particular time. Applicant must provide full address at time of application.
- Satisfactory evidence of an applicant's identity and date of birth expanded to include a
  foreign passport with an expired temporary I-551 stamp or printed notation with a US
  DHS admission stamp, US DHS Form I-94 or I-94A with photograph and unexpired
  temporary I-551 stamp, US Dept. of State form DS-232 with US DHS admission stamp.
- If the Forms I-551 or I-766 validity period has been automatically extended by the federal DHS, it is deemed unexpired, regardless of the expiration date listed.
- Technical corrections to internet service and cable service utilities.
- Social Security number removed from exceptions process.

 The report must identify the performance measure or metrics established by the commissioner and the results, the number of tests administered per month for the previous five fiscal years, factors that impact road test examination appointment availability, and analyze data on road tests administered outside the applicant's county or region.

 Adds "or approved" to the type of driver education program that may offer online driver education.

# **Repeal Commercial Motor Vehicle Testing Program**

#### What you need to know:

 Repeals the rule requiring a public, postsecondary educational institution or school applying to be a third-party testing program for commercial motor vehicles to offer a training course for commercial motor vehicle operation that consists of at least 180 hours of training.

# **Repeal Course Length Restrictions**

## What you need to know:

- Defines a "roadable aircraft" as a "motor vehicle" and "passenger vehicle." Roadable aircraft are excluded from the definitions of an autocycle and motorcycle.
- Roadable aircraft will have dual registration as an aircraft and a passenger vehicle. Titled as an aircraft. This will be a registration-only record in MNDrive.
- No plates will be issued to a roadable aircraft. Registration will be recorded under the
  federally issued tail number assigned to the roadable aircraft and they will be issued a
  registration certificate when all motor vehicle registration fees and taxes are paid.

#### **Pickup Truck Technical Correction**

- Adds language clarifying that the funds in the Minnesota professional sports team foundation account in the special revenue fund will be annually appropriated.

# **Foreign Passports for Vehicle Title Applications**

## What you need to know:

• Dealer must title a vehicle in the name of a new owner or the dealer in order to apply for replacement plates.

• Dealer must remove plates from a vehicle and dispose of them when placing a vehicle in held for resale status.
