# Requesting an Expedited Title

**E-MAIL VIA DEPUTY REGISTRAR:** Applications will be processed by submitting scanned documents as an e-mail attachment to [dvs.fast.track@state.mn.us](mailto:dvs.fast.track@state.mn.us)

- **Deputies (Certified Title Clerks)** will review all documents for completeness and accuracy; scan and email the documents, along with any necessary supporting documents to DVS Fast Track office.
- **DVS Fast Track** reviews the documents, approves or denies the application, and preforms the data entry of the title transfer information.
