TECHNOLOGY SURCHARGES

Effective August 1, 2019

Title and Registration Technology Surcharges Effective August 1, 2019

- Technology surcharges of \$2.25 are due on most registration and title transactions.
- Customers who do a renewal in conjunction with a title transfer will owe two technology surcharges, the registration technology surcharge and the title technology surcharge.

Registration Technology Surcharge - \$2.25

Transaction Type	Does fee apply?	
Registration Renewal	Yes	
Registration renewal with title transfer	Yes	
Partial Pay Transactions	Yes, one fee per registration installment transaction.	
Farm Quarter Transactions	Yes, one fee per quarter registration transaction. For example, only one fee is due for a renewal of two or more consecutive quarters.	
Daily rental renewals	Yes, regardless of the number of months of registration requested.	
Multiple year registrations	Yes, only one fee is due.	
	 Exception: small trailers that have the option of renewing registration for three years. The technology surcharge is due for each registration year. 	
Dealer plate renewals	Yes	
Drive-away in-transit license renewals	Yes	
Registration renewal with repossession	Yes	
Fleet renewals	Yes, a fee is due for each vehicle in the fleet	
Initial registration in Minnesota (new-to-fleet with MCO or out-of-state title)	No	
Back-in-Again	Yes	
Change of class (Takes place at time of renewal)	Yes. For example, changing from passenger class to collector class. This would not apply to plate type changes (e.g., Moose critical habitat plates to Loon critical habitat plate).	
Conversions (Takes place after registration was renewed for registration period.)	No

Transfer on Minnesota title (with or without registration renewal)	Yes
Duplicate title application	Yes
Adding or removing lienholder	No
Adding or removing lessee	No
Repossession	Yes
Title correction (e.g., name change)	Yes, unless the correction is because of a DVS or deputy registrar error.
