IRP TRANSACTIONS		
New Account Invoice Payment	One (1) \$11 filing fee for each vehicle registered and issued an IRP credential.	<ul style="list-style-type: none"> <li>For example: if registration is issued to two vehicles on the IRP account, \$11 is charged for each vehicle for a total of \$22.</li> <li><b>Note:</b> If the carrier pays the invoice the same day as the invoice date, the deputy should contact the DVS office for a revised invoice waiving the DVS filing fee.</li> </ul>
IRP Account Renewal	One (1) \$11 filing fee for each vehicle renewed and issued an IRP credential.	<ul style="list-style-type: none"> <li>For example: if registration and credentials are issued to 10 vehicles, the total filing fee is \$110 (\$11 x 10 vehicles).</li> </ul>
IRP Renewal - Invoice Only	One (1) \$11 filing fee for each vehicle invoiced, when the carrier requests an invoice only (payment will be made another day).	<ul style="list-style-type: none"> <li>For example: if 10 vehicles are invoiced, the total filing fee is \$100 (\$10 x 10 vehicles).</li> </ul>
IRP Renewal Payment Only	One (1) \$11 filing fee for each vehicle issued an IRP credential, when the carrier returns to complete the renewal.	<ul style="list-style-type: none"> <li>For example: if credentials are issued to 10 vehicles, the total filing fee is \$110 (\$11 x 10 vehicles).</li> </ul>
IRP SUPPLEMENT TRANSACTIONS		
An IRP supplement can include any combination of the following ten transactions		
Add/Delete	Charge one (1) \$11 filing for each vehicle that is added and/or deleted, at the same time.	<ul style="list-style-type: none"> <li>For example, if one vehicle is added and one vehicle is deleted at the same time, the total filing fee is \$22 (\$11 x 2 transactions),</li> <li>This includes transactions that may require a Minnesota application for title.</li> </ul>
Delete Only	One (1) \$11 filing fee for each vehicle deleted on the IRP supplement.	
Gross Weight Increase	One (1) \$11 filing fee for each vehicle affected.	
Gross Weight Decrease –	One (1) \$11 filing fee for each vehicle affected.	
Replacement Plate and Cab Card	One (1) \$11 filing fee for each vehicle affected.	<ul style="list-style-type: none"> <li>For example: if you issue replacement plates and new IRP cab card to 10 vehicles in the IRP fleet, the total filing fee is \$110 (\$11 x 10 vehicles).</li> <li>A replacement plate includes the weight and year stickers.</li> </ul>

<b>IRP SUPPLEMENT TRANSACTIONS (CONTINUED)</b>		
Replacement Year Sticker and Cab Card	One (1) \$11 filing fee for each vehicle affected.	<ul style="list-style-type: none"> <li>For example: if you issue replacement stickers and new IRP cab cards to 10 vehicles in the IRP fleet, the total filing fee is \$110 (\$11 x 10 vehicles).</li> </ul>
Replacement weight sticker	One (1) \$11 filing fee for each vehicle affected.	
Replacement Plate, Weight Sticker, Year Sticker, and Cab Card	One (1) \$11 filing fee for each vehicle affected.	<ul style="list-style-type: none"> <li>For example: if you issue replacement plates and stickers and issue new IRP cab cards to 10 vehicles in the IRP fleet, the total filing fee is \$110 (\$11 x 10 vehicles).</li> </ul>
Corrected cab card	One (1) \$11 filing fee for each vehicle affected.	
Close IRP Account	No fee	Per MN Statute 168.33 (6) (1)
<b>IFTA TRANSACTIONS</b>		
New IFTA License	One (1) \$11 filing fee for payment and issuance of license/decals.	Per Minn. Stat. 168.33 Subd. 7 (2) the \$11 fee is imposed on the motor carrier fuel license.
IFTA License Renewal or Reinstate IFTA License	One (1) \$11 filing fee for processing payment and issuance of license/decals.	
Reprint or Modify/Edit license	No fee	
Order Additional Decals	No fee	
Cancel License	No fee	
Process Quarterly Tax Return	No fee
